A robust asset management system helps make the most of your assets while balancing financial, environmental and social costs, risk, quality of service and performance.

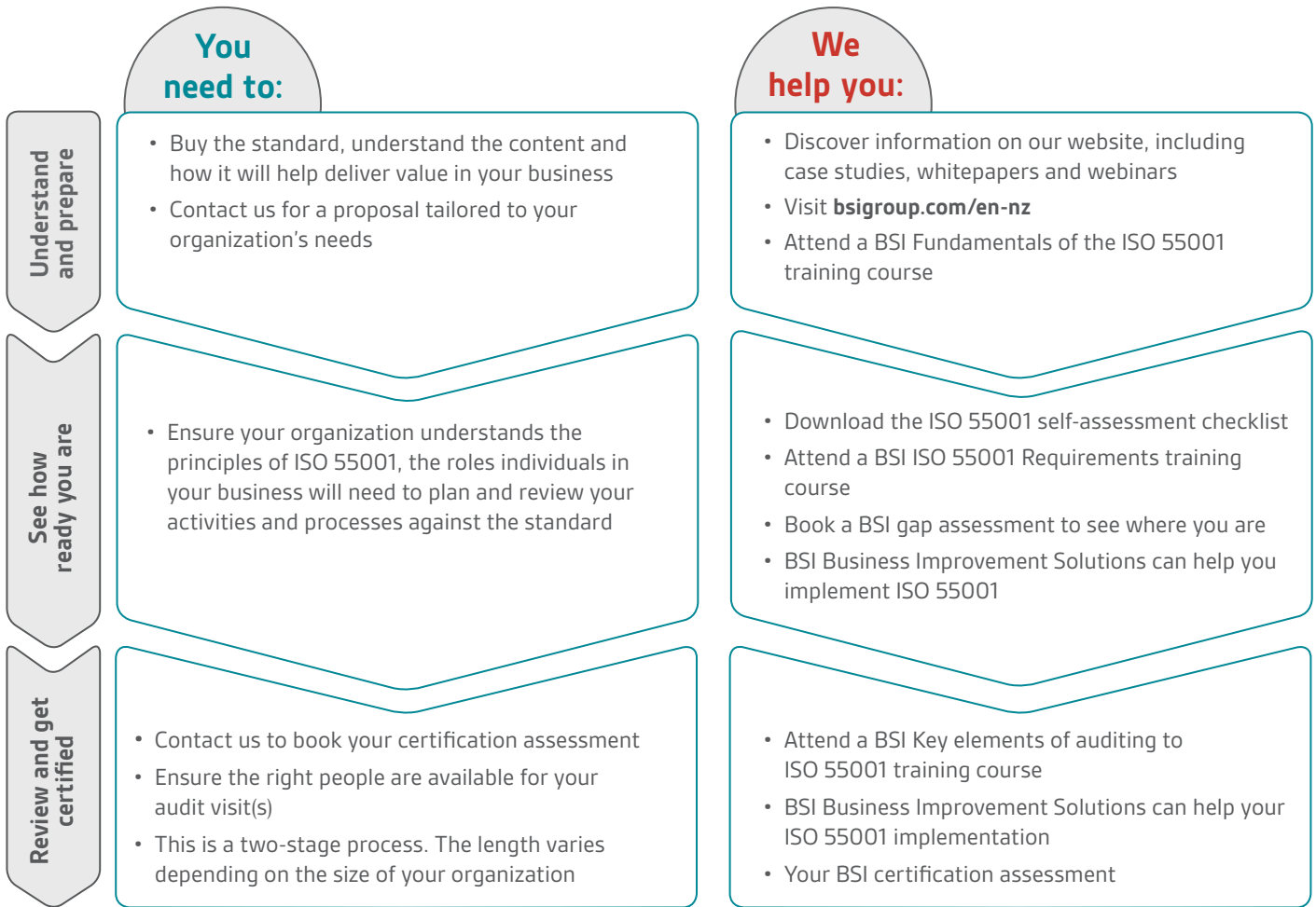
