Invitation to comment on MSPO Initial Assessment of Boustead Plantation Berhad – Segaria Palm Oil Mill and supply base, Semporna, Sabah, Malaysia

Boustead Plantation Berhad has appointed BSI to conduct MSPO Initial Assessment of its Segaria Palm Oil Mill and supply base. The assessment will be conducted at 1 Palm Oil Mill and 1 Oil Palm Plantation which are managed by the company. The certification unit is located at Semporna, Sabah, Malaysia
