Invitation to comment on MSPO Initial Assessment of Genting Plantations Berhad – Genting Ayer Item Palm Oil Mill and supply base, Air Hitam, Johor, Malaysia

Genting Plantations Berhad has appointed BSI to conduct MSPO Initial Assessment of its Genting Ayer Item Palm Oil Mill and supply base.
