A well-designed Occupational Health and Safety (OH&S) Management System has to address its risks and opportunities. These may arise from the organization's hazards, legal and other requirements or from other issues relating to the organization's context.

An organization's management system, although based

on the common ISO 45001 standard, may differ from others due to its risks and opportunities. Therefore, understanding risk-based thinking is crucial so that actions can be integrated into the organization's processes for them to function as an effective coherent system.
