Why is the BSI Kitemark important?

The BSI Kitemark for protective barrier systems (widely referred to as a balustrade) is a unique certification scheme, applicable to suppliers of balustrade systems, constructed from glass and/or metal, for use in and around buildings.

Balustrades are increasingly being used in modern buildings. They can be visually stunning but any new glass or metal balustrade must be designed in such a way to ensure the product is safe. The dangers of an unsafe balustrade system are both financial and life threatening. Demonstrate the quality of your product with the BSI Kitemark.

In order to achieve a BSI Kitemark, manufacturers submit balustrade samples intended for certification to an independent laboratory for testing against various key industry standards. As the performance of the balustrade is dependant on all the elements within the structure, the quality of the materials used is regularly monitored. Failure of even the smallest component can have catastrophic consequences for the installed system.

Supplier management systems are monitored on a regular basis to help ensure consistency, safety and quality is maintained. This is what we believe sets the BSI Kitemark apart, going above and beyond many other certification schemes.

How can I achieve the BSI Kitemark or CE marking?

For a manufacturer to achieve the BSI Kitemark and/or CE marking, the following steps typically need to be taken:

- Initial laboratory type testing of the product
- Initial assessment of the manufacturing site and associated manufacturing quality plan (usually to a recognized Standard such as ISO 9001).
