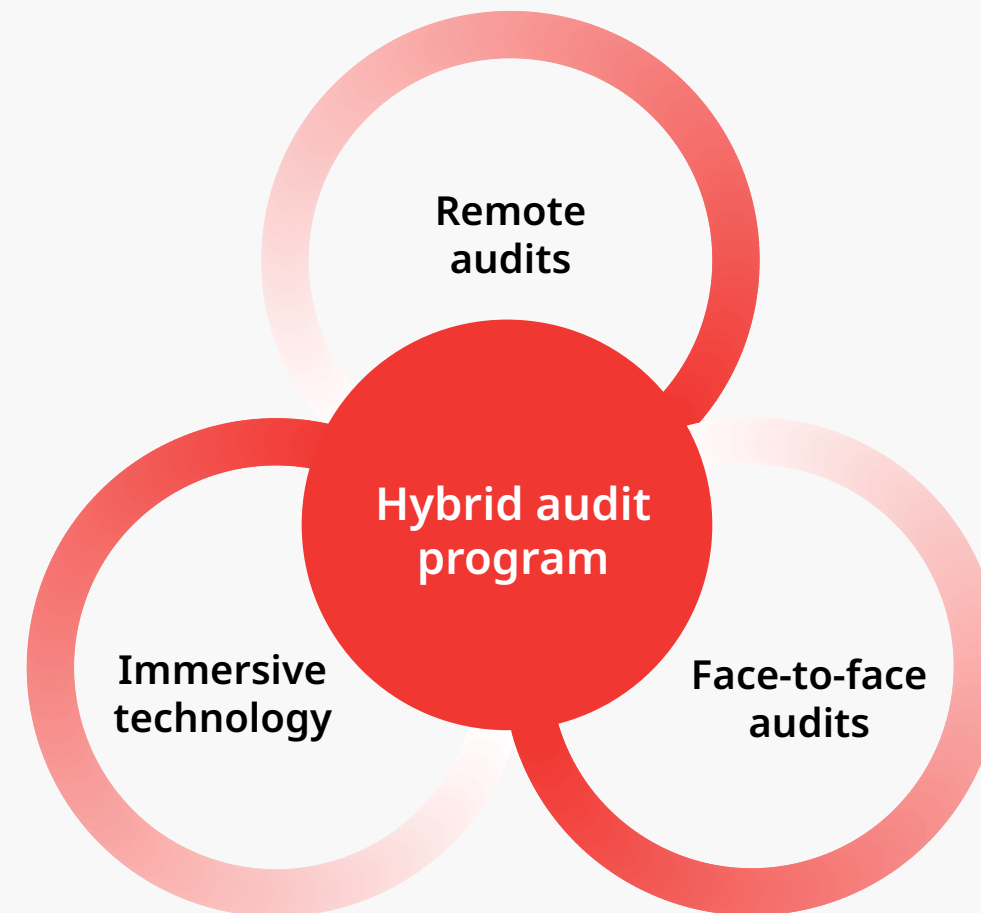

● Is a hybrid audit program the same as a remote audit?

No. Hybrid audit programs do use remote audits but combine them with on-site auditing wherever this adds more value – when reviewing an organization's operation, support and resources, for example, or when on-site is required by the audit scope. In some instances, a client's audit program may specify face-to-face audits only.
