An integrated approach

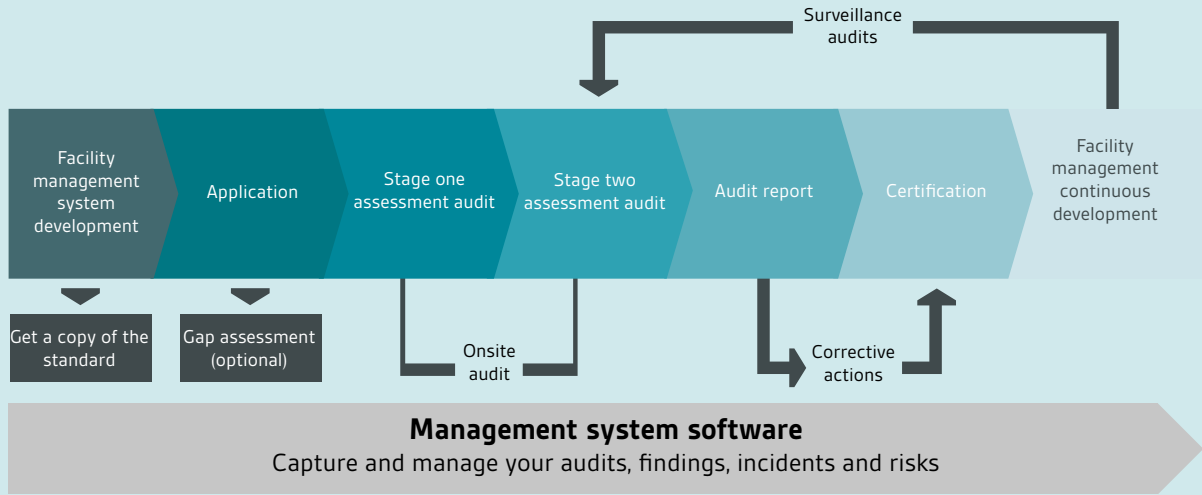
