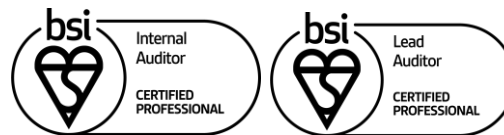

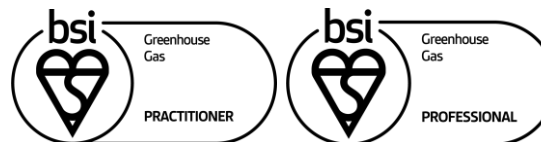

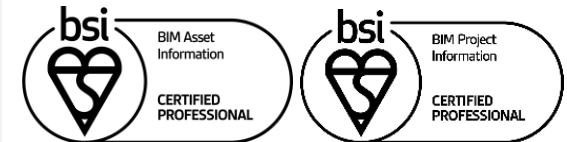

Two stages (practitioner and professional)



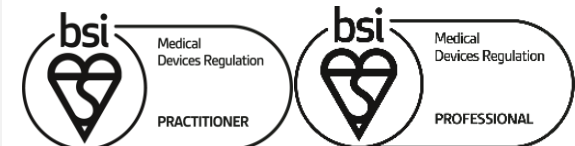
